Option A: The student must appear in person at the College of Southern Nevada to verify their identity by presenting a valid, unexpired government-issued photo identification (ID), such as, but not limited to, a driver’s license, other state-issued ID, or passport. The institution will maintain a copy of the student’s photo ID that the institution annotates with the date it was received and reviewed and the name of the official at the institution authorized to receive and review the student’s ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

Option B: If the student is unable to appear in person at College of Southern Nevada to verify their identity, the student must provide to the institution:
(a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver’s license, other state-issued ID, or passport; **and**
(b) The original Statement of Educational Purpose provided below, **which must be completed in person with a notary and notarized**. Online notaries are not accepted. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
(c) Once notarized, the student must mail the notarized form along with a copy of their valid government-issued photo ID to: CSN Financial Aid Office, 6375 W. Charleston Blvd., Sort Code WCD 126, Attn: Verification, Las Vegas, NV 89146.
